- Applicant will be notified by email / phone of acceptance or denial
- Applicant will be notified of orientation date and time (typically 10:00 AM on Saturday of first full weekend of the month, outdoor ranges are closed to shooting)
- Orientation given to applicants. Orientation starts promptly at the designated time. If you cannot make it or are late contact the club membership officer and reschedule for the next month's orientation
- Photo taken of applicant for future electronic access card
- For approved applicants gate keys will be distributed to applicants at the next scheduled club meeting (except summer hiatus months). Contact the club membership officer if it is necessary to make alternative arrangements
- Indoor range key given upon qualification on the indoor range
- Denied applicants will be refunded their application fee
